Accommodation: Due to acute shortage on the housing market it is extremely difficult to find accommodation in the Lausanne area and students should plan well ahead. A restricted number of rooms are available in the framework of an agreement with the FSLE foundation for student halls. Contact them per e-mail: fsle@unil.ch		
Visa/Work Permit: Applicants from countries subject to a visa obligation for a stay over three months must file their visa application from abroad, to be issued a student entry visa by a Swiss embassy or consulate. Please verify by this search engine if you need a visa and which embassy to contact: https://www.swiss-visa.ch/register/i210_select_country_view.action To obtain a student visa, applicants should apply to the Swiss diplomatic representation closest to their home abroad, specifying the chosen curriculum and foreseen duration of studies. Documents required: <ul style="list-style-type: none"> - Valid passport; - ECAL enrolment certificate; - Documents in proof of your financial means during your studies in Switzerland (taking secondary employment while studying is only allowed at least six months following the start of your course). It takes minimum 2 to 3 months to obtain a student visa (student B permit). Students not subject to a student visa obligation only need to comply with the procedure to be followed on arrival in Switzerland.		

Procedure to be followed on arrival in Switzerland:

All foreign students, including those who need a visa, must register with the residents' office ("Contrôle des habitants") of their commune of residence within 8 days. Contact details for Lausanne:

To apply for a residence permit, a foreign student should submit the following:

- *Passport with student visa if required;*
- *ECAL enrolment certificate;*
- *2 passport photos;*
- *Arrival report ("rapport d'arrivée");*
- *Certificate of Swiss or foreign study grant or cost coverage certificate (whereby someone else pledges to cover your costs);*
- *Lease or contract from the landlord.*

Applicable fees to obtain a residence permit:

- *EU/EFTA students: CHF 95.-*
- *Non-European students: CHF 147.-*

Health Insurance:

Taking out health insurance is compulsory for foreign students wishing to stay in Switzerland for over three months. However, according to Article 3, § 2 of the Swiss Federal Law on Compulsory Health Care (LAMal), the Federal Council may exempt certain categories of persons from mandatory health insurance, in particular representatives of foreign States and officials of international organisations. Insured persons with one of the above statuses who have insurance providing equivalent coverage according to Swiss law will be issued an exemption for the duration of their stay in Switzerland.

The following students are exempted:

- **From an EU country with social security:** these students must submit a copy of their European Health Insurance Card (EHIC);
- **From an EU country without social security, but covered by private insurance:** these students must fill in the [form to establish equivalent health insurance coverage](#);
- **From a non-EU country, but covered by private insurance:** These students must fill in the [form to establish equivalent health insurance coverage](#).

Students unable to validate their insurance in Switzerland or to take out approved coverage in their home country must take out health insurance in Switzerland:
